Our colleagues are at the heart of our business. We do all we can to support and develop them in their careers and on a personal level; ensuring that we do all we can to focus on health and wellbeing.



OUR BENEFITS

We offer a wide range of benefits to our colleagues and it's growing all the time! We prioritise our people, which means when you become a part of our team you will receive a generous holiday entitlement, life cover, income protection, access to a health cashplan, discounts on shopping and gym memberships, an employee assistance programme and performance related pay. We look after our colleagues and want them to be healthy, happy and secure.

Group Life Assurance Scheme

A Group Life Assurance Scheme is there to provide peace of mind to our colleagues. The cover is 3x salary and also includes telephone and face to face bereavement support and counselling.

Group Income Protection Scheme

This scheme is designed to provide protection for our colleagues, who are unable to work due to long term illness or injury. We look after our colleague's welfare as best we can, both with individual support as well as financial stability when it is needed the most.

✓ Pension Scheme

We operate our pension on a Salary Exchange basis, which is a flexible, tax efficient way of contributing to a pension fund. Colleagues save National Insurance (NI) on pension contribution, benefit from immediate tax relief and receive a top up by way of a further NI.

✓ Health Cash Plan

A Health Cash Plan is there to help colleagues manage everyday health costs by offering re-imbursement on a range of treatments, including dental, medical consultations and physiotherapy.

In addition, our policy includes a Virtual GP Service so that colleagues can access a video consultation with a UK based GP directly from your smartphone or tablet. Colleagues have access to a GP when at home or at the office, without waiting days or weeks for an appointment.

Employee Assistance Programme

Colleagues get confidential support and advice with this programme, in relation to Financial Wellbeing, Mental Wellbeing and Physical Wellbeing.

✓ Performance Related Pay
